

#### Video surveillance Personal Data Protection Policy

(Pursuant to Art. 13 of European Regulation No. 679/2016)

Trenitalia S.p.A. invites you to carefully read the policy regarding personal data protection in relation to the images acquired through the video-surveillance systems installed on board trains, on permanently installed equipment and on self-service machines.

#### I. Data Controller and DPO

### II. Types of personal data

In this section, we indicate the types of data we request

• **Multimedia data acquired:** videos captured by the cameras installed on board trains, on permanently installed equipment and on self-service machines. The aforementioned data will be processed using electronic and paper-based formats in order to guarantee suitable measures of security and privacy.

#### III. Purpose of Data Processing

In this section, we indicate the purpose of the processing carried out on your data

Protection of personnel and of company assets, and for organisational and/or production needs (e.g. to count the number of people); Nature of the provision: (*Mandatory*); Legal basis: (*Legitimate interest*)

The provision of the data necessary to pursue the purposes referred to above is "mandatory" in nature. The recordings are made by the Data Controller with the intention of pursuing its legitimate interests by gathering evidence allowing it to protect its personnel and company assets, including from potential attacks, theft, robbery, damages and vandalism; or for the purpose of preventing fires and ensuring work safety.

### IV. Data recipients

- Judicial authorities

Only parties expressly authorised by Trenitalia S.p.A. shall be permitted to view the live and recorded images in full.

The images may also be accessed by companies acting as **Data Processors** on behalf of Trenitalia S.p.A., which have signed specific contracts that duly regulate the processing entrusted to them and their obligations regarding data protection. Your data will never be disseminated.

# V. Data storage

In this section, we indicate the length of time your data will be stored

The images recorded via the video-surveillance systems shall be stored for a maximum period of 7 days from their capture, after which they shall be automatically deleted by means of overwriting them. This is without prejudice in all cases to the possibility of storing the images beyond said period in the event of a request related to an investigation from the Judicial Authorities or the Police.



#### VI. Rights of the Data Subjects

In this section, we indicate the rights we guarantee

EU Regulation 2016/679 (Articles 15 to 23) grants data subjects the option to exercise specific rights. In relation to the processing of your personal data, you have the right to ask Trenitalia S.p.A. for access to the data concerning you (given the nature of the data being processed, the exercise of this right must be balanced against protecting the privacy rights of third parties or of the Controller), or for the limitation or erasure of the data in the event of processing which violates the law. Given the intrinsic nature of the data collected, you may not seek to have them rectified and/or modified, as the images pertain to objectively recorded facts. Moreover, you may not exercise the right to portability or to object to processing, as the processing is not based on your consent or on a contract but on the legitimate interests of Trenitalia S.p.A.
