

Prize Promotion “CartaFreccia”

Regulations (Art. 10, para. 3, Presidential Decree of 26 October 2001 No. 430)

Art. 1 - Promoter

Trenitalia S.p.A. (hereinafter, the “Promoter” or “Trenitalia”), Piazza della Croce Rossa 1, 00161, Rome, Tax Code and VAT no. 05403151003.

Art. 2 - Delegated Party

Alkemy S.p.A., with registered office at Via San Gregorio no. 34, 20124 Milan (MI), Tax Code and VAT no. 08462130967.

Art. 3 - Name

“CartaFreccia” (hereinafter, also the “Prize Operation” or, for brevity, the “Operation”).

Art. 4 – Recipients

The Prize Operation is aimed at all end customers, natural persons, holders of one of the “CartaFreccia”, “CartaFreccia Argento”, “CartaFreccia Oro”, “CartaFreccia Platino” or “CartaFreccia Platino Infinito” cards (hereinafter referred to as “Card” or, jointly, “Cards”), in all the types provided for (currently in the “Argento”, “Oro”, “Platino” and “Platino Infinito” types; in the future, they may also be provided in other types and with other and/or different names) issued by the Promoter (hereinafter referred to as “Holders”).

Participation in the Prize Operation is not permitted by parties who do not fall within the definition of Holders (by way of example and not limitation: travel agencies, tour operators, resellers in general).

Art. 5 – Purpose

The purpose of the Prize Operation is to promote the sale of rail tickets (“Tickets”), season tickets (“Season Tickets”) and carnets (“Carnets”) on “Frecciarossa”, “Frecciargento”, “Frecciabianca” trains, in any class or service level (hereinafter, in addition to being individually defined as “Ticket”, “Season Ticket” and “Carnet”, when named jointly, also “Travel Documents”).

The Travel Documents valid for the purposes of this Prize Operation can be purchased at the website www.trenitalia.com or through the Trenitalia App, station ticket offices, the FRECCIALounge/FRECCIAClub, Trenitalia travel agencies, the paid call center (at number 892021 and with costs borne by the customer as specifically indicated in the following article 8) and the self-service ticket machines of the national circuit.

Art. 6 – Duration

The Prize Operation is valid from 1 June 2022 until 31 December 2026 (corresponding to the points collection period, hereinafter the “Promotional Period”), subject to any extensions that will be promptly announced.

The points accrued during the Promotional Period may be used by Holders to request prizes from 16 June 2022 and no later than 31 March 2027.

Art. 7 - Territorial extension

The Prize Operation is valid throughout the Italian national territory and the Republic of San Marino (hereinafter “Territory”).

Art. 8 - General description

The Prize Operation constitutes a points-based promotional initiative aimed at Holders, which allows them to:

- accumulate points through the purchase of Travel Documents;
- accumulate points as a result of specific agreements between the Promoter and other partner companies as indicated in detail on the website www.trenitalia.com;
- These Rules govern the methods of enrollment in and conduct of the Prize Operation.

The Promoter reserves the right to modify, even partially and at any time, the methods of enrollment in and conduct of the Prize Operation, without prejudice to the rights acquired by Holders, in compliance with their equal treatment and in accordance with the applicable regulations.

For further information on the Prize Operation or for any clarifications on these Rules, it is possible to call the Trenitalia Call Center at number 892021 (costs at the time these Rules come into effect: from a landline, a connection charge of 30.5 euro cents including VAT and a per-minute cost of 54.9 euro cents including VAT; from a mobile phone, the rate provided by one's own tariff plan applies, depending on the mobile phone operator. The Promoter reserves the right to vary these rates at any time, providing appropriate information to customers) or access the website www.trenitalia.com.

Art. 9 - Conditions and methods of enrollment

Participation in the Prize Operation is governed by these Rules and entails, for the Holder, the unconditional and total acceptance of the rules and clauses contained therein, without any reservation and/or limitation, upon enrollment in the Prize Operation.

Participation in the Prize Operation is subject to the full and timely compliance with all the terms, clauses and conditions set out in these Rules, without any reservation and/or exception.

Enrollment in the Prize Operation is necessarily subject to holding one of the Cards issued by the Promoter.

Enrollment must take place through the following channels:

- by filling in the relevant form at the internet address www.trenitalia.com, in the “CartaFreccia” section;
- at the assistance offices/counters, located in stations where present, and/or at the ticket offices in all other cases;
- by filling in the relevant form through the Trenitalia App;

- through the Travel Agencies participating in the Operation.

Details on how to obtain the Cards and their specific characteristics are available on the website www.trenitalia.com, in the relevant section concerning the Cards.

The Card is personal, registered in the Holder's name, non-transferable and may be used only by the relevant Holder.

Each enrollment is registered in the name of the Holder and entails that the Holder, having first consulted the privacy notice on the processing of personal data, provides their own personal data, with the obligation to communicate any changes thereto through the website www.trenitalia.com. The Holder guarantees the correctness and truthfulness of all the information provided to the Promoter and is solely responsible for it, on an exclusive and full basis.

In the event of improper use of the Cards, in particular for points accumulated in relation to travel carried out by a person other than the Holder (see the following article 10, paragraph 2), the Promoter reserves the right at any time to cancel the latter's enrollment in the Prize Operation, with the consequent loss of the accumulated points, as well as to undertake any type of action and/or initiative (by way of example and not limitation, the suspension of the Card) to protect its own rights, interests and reasons.

Holders have the right to request withdrawal from the Prize Operation at any time by accessing the Reserved Area on the website www.trenitalia.com through the "Cancel enrollment" section. The Holder has the right to withdraw from the Prize Operation immediately or starting from the next CartaFreccia program. The withdrawal relates to the Prize Operation, while registration on the website www.trenitalia.com will remain active.

Upon immediate withdrawal from the Prize Operation, if no prize is requested beforehand, the points accumulated up to that point will be lost.

Any point-earning behavior carried out by the Holder in the period prior to enrollment in the Prize Operation will in no case contribute to the accumulation of points, being excluded therefrom.

Art. 10 – Points accumulation

All Holders, starting from the date of enrollment in the Prize Operation, will accumulate points according to the parameters and methods set out in the following Table 1.

Only journeys made by the Card Holder on the trains indicated in the previous table and operated by Trenitalia S.p.A. give the right to accumulate points.

Points credited in relation to journeys made by a person other than the Holder will be cancelled. In such a case, the Promoter reserves the right, at any time and at its sole discretion, to suspend or cancel the Holder's enrollment in the Prize Operation, with the consequent cancellation of the accumulated points, and/or to take any initiative deemed suitable to protect its own interests, reasons and rights.

Journeys on trains not expressly indicated in the previous table do not give the right to accumulate points.

Furthermore, the following types of tickets do not give the right to accumulate points:

- ticket changes and tickets purchased on board the train;
- tickets purchased through channels other than the following: www.trenitalia.com, Trenitalia ticket offices, FrecciaLounge, FrecciaClub, Self-Service ticket machines of the national circuit, Trenitalia travel agencies, Trenitalia App, Trenitalia Call Center;
- tickets relating to promotional offers, unless otherwise indicated in the commercial conditions of the specific offer;
- admission rights, "Tutto Treno" cards and similar;
- tickets relating to international journeys unless otherwise indicated on the website www.trenitalia.com;
- tickets not used by the Holder, even if purchased by the Holder.

For the crediting of points, the Holder must, at the time of purchasing the Travel Documents, provide the Promoter with the personal code of their own Card, in the specific manner for the various sales channels, and verify that the code is correctly shown on the Travel Document.

The Trenitalia staff in charge of checking will verify the exact correspondence between the personal code indicated on the Travel Document and the one shown on the Card. The Holder is in fact required to carry their own Card, including the temporary paper version or in digital format or in a photograph (provided that both the Holder's first and last name and their personal code are legible), throughout the entire journey.

The Trenitalia staff, moreover, will have the right to identify the Holder by means of a suitable identity document. Pursuant to the General Conditions of Carriage, the Trenitalia staff in charge of checking may also verify whether the Travel Document was issued in compliance with the rules provided for therein.

The Promoter reserves the right to verify at any time that the accumulation of points and the relevant balance comply with the Rules of the Prize Operation and with any provision related thereto and, in the event of conduct that is inconsistent and/or non-compliant, to undertake any type of action and/or initiative (by way of example and not limitation, the suspension of the Card, withdrawal from the Prize Operation, the cancellation of points) to protect itself.

Further checks may be carried out upon the prize request.

Points are available for requesting prizes only after the date on which the journey is made, within 3 (three) days from the date on which the journey is made, even in cases where the relevant crediting takes place before the journey itself is made.

The sum of the points available for requesting prizes, net of the points used, is defined as the “Prize Points Balance”.

Conversely, the “Accounting Points Balance” is the sum of the Prize Points Balance and the points relating to journeys purchased and not yet made, always net of the points used.

The Holder, by accessing the Reserved Area on the website www.trenitalia.com, will have the option to view both the “Accounting Points Balance” and the “Prize Points Balance”.

In the event that, after 3 (three) days have elapsed from the date on which the journey was made, the points have not been credited, despite the CartaFreccia code being correctly shown on the Travel Document, it is possible to request assistance within the Reserved Area on the website www.trenitalia.com.

After purchase, it is possible to recover, for the purpose of crediting points, only the Frecce, Eurocity and Euronight tickets that show the first and last name of the Holder for which the CartaFreccia code was omitted at the time of purchase. The Holder may proceed to recover the points connected to the Travel Document independently from their own Reserved Area on the website www.trenitalia.com, in the “Recupero Punti” (Points Recovery) section, within 30 (thirty) days of purchase.

The stubs of the purchased Travel Documents must be kept until the points are credited by Trenitalia.

In the event that a Holder requests a full or partial refund of the Travel Document, the aforementioned refund, even if partial, will entail the elimination of the entire value of the points credited following the purchase of the Travel Document subsequently refunded.

The Promoter, in some periods of the Prize Operation, may activate promotional initiatives, limited in time, relating to the recognition of more favorable conditions for crediting points (e.g. the granting of double or additional points for certain point-earning behaviors), which will from time to time be duly communicated to the Holders involved through the website www.trenitalia.com and by all other means deemed suitable.

The Promoter also reserves the right to provide for, during the duration of the Prize Operation, new and/or additional point-earning actions, in addition to those indicated so far, even for limited periods of time, of which due communication will be given to Holders in the same manner and by the same means used for the publicity of these Rules, indicating the respective points, the duration period, as well as the methods by which the data is acquired by the Promoter (automatically or following upload by the interested Holder).

It is understood that, with the exception of the periods expressly indicated in the respective communications, only the terms and conditions for awarding points set out in these Rules will be valid.

The accumulated points are valid for requesting prizes no later than 31 March 2027 and may in no way be converted into money.

Art. 11 – Benefits and points offered by Partners

The Promoter may develop specific agreements for participation in the Prize Operation with Partner companies, providing for the crediting of points:

- for the purchase of goods and/or services from the Partner companies;
- in substitution for a portion of the points accrued in the specific loyalty program of the Partner companies (so-called points exchange).

The Holder shall take care to communicate their own personal Card code to the Partners themselves, at the Partners or on the website www.cartafrecciacollection.com at the time of purchase or of the points exchange request.

Please note that for some Partner companies, the list of which will be available at <https://www.trenitalia.com/it/cartafreccia/guadagna-punti-dai-partner.html>, the crediting of points will take place exclusively through the entry of a unique code, previously issued by the Partner according to the methods provided by the Partner itself, in a specific section of the website www.cartafrecciacollection.it.

The points relating to such initiatives may be credited up to 75 (seventy-five) days after the initiative itself. In the event of failure to credit, it is necessary to contact directly the customer service of the Partner concerned, which will process the personal data provided as an Independent Data Controller.

The points credited by virtue of such initiatives will follow the same conditions (duration, usability, etc.) as the points normally credited by the Promoter.

The Partners of the Prize Operation are solely responsible for the conditions for crediting points.

The Holder is required to verify, at the Partners themselves or on the website www.cartafrecciacollection.com, the conditions in force.

Trenitalia disclaims all responsibility regarding the services and products offered by the Partners.

The complete and always up-to-date list of all Partner companies and the respective methods of accumulating points are available at the following address <https://www.trenitalia.com/it/cartafreccia/guadagna-punti-dai-partner.html>.

Art. 12 – Validity and use of points

All accumulated points may be used by the Holder to request the prizes in the catalogue, referred to in Annex 1 to these Rules, which can be consulted on the website www.trenitalia.com.

Upon reaching the required score, the Holder will be entitled to request the chosen rail prize according to the following methods:

- by calling the Trenitalia Call Center; the Holder will provide the operator with the data necessary to be identified, which will be processed in compliance with the provisions of the privacy notice for the protection of personal data that they reviewed during registration, and will request the prize in which they are interested; the operator will verify the entitlement to the prize and will proceed with the assignment;
- by accessing the internet website www.trenitalia.com: the registered Holder, once having entered the Reserved Area, based on their own points balance, may request the rail prize. Following the request, an e-mail will be sent, to the address indicated upon enrollment in the Prize Operation, containing all the data to use the requested rail prize;
- by accessing the CartaFreccia section on the Trenitalia App: the registered Holder, having logged into the dedicated section, based on their own points balance, may request the rail prize. Following the request, an

e-mail will be sent, to the address indicated upon enrollment in the Prize Operation, containing all the data to use the requested rail prize;

- at the FrecciaLounge and FrecciaClub, only for Holders entitled to access them, with the support of Trenitalia staff;
- at the dedicated counters of the authorized Trenitalia ticket offices.

Rail prizes are registered in a name and may be used both by the Holder and by a third party, whose name must be entered at the time the prize is issued, with the exception of the prize upgrade, which may be used only by the Card Holder.

Once the rail prize has been issued, it is not permitted to make changes of any kind, nor to request a refund, unless otherwise indicated.

Only in the event of a delayed arrival of the train used with the rail ticket/prize is a refund provided by re-crediting the points in the following measure:

- 25% of the points used to request the prize for a delay of between 30 and 119 minutes;
- 50% of the points used to request the prize for a delay of at least 120 minutes.

Re-crediting in points is not provided for the Freccie Gift Cards.

It is possible to request the refund in points once 24 hours have elapsed from the making of the journey and up to 12 (twelve) months after the date on which the delay occurred, solely by opening an Assistance Request through the “Assistenza Cartafreccia” section present in the Reserved Area on the website www.trenitalia.com.

By the same request method, a bonus equal to 25% of the points used to request the prize is also granted, in the event that, in the carriage where the traveler took their seat, the air conditioning system is completely non-functioning and if it is not possible to assign a seat in another carriage of an equal or higher class or service level. The Holder loses the right to be granted the bonus in the event of refusal of accommodation in another available seat on another carriage of an equal or higher class or service level.

Where, for the same journey, the conditions for both the points refund for delay and the points refund for failure of the air conditioning system apply, the two benefits are not cumulative and, therefore, the Holder is entitled only to the re-crediting of the points for delay.

In both cases, the re-crediting of the points will take place on the CartaFreccia collection in progress at the time of the refund.

Stolen and/or expired rail prizes cannot be re-issued and the Holder will lose the right to the relevant journey.

In the event that the Holder is unable to use the prize, they will not be entitled to the payment of any sum of money.

In the event that the Promoter reserves the right to introduce additional prizes, gifts and services (not necessarily linked to the Promoter), the latter may be requested by the Holder by accessing the website www.trenitalia.com; the registered Holder, having entered the Reserved Area, based on their own points balance, may request the chosen prize.

Prizes may be requested from 16 June 2022 and no later than 31 March 2027.

All points accumulated and not used by 31 March 2027 will be automatically zeroed out, as will all points accumulated and not used for Holders who request withdrawal from the Prize Operation. In the event of withdrawal and subsequent re-enrollment in the Prize Operation, any points accumulated and not used before the withdrawal cannot be recovered. The Holder may accumulate points again starting from the date of re-enrollment in the Prize Operation; there is no retroactive validity of the points accumulated from the withdrawal to the re-enrollment.

Art. 13 - The prizes

The points accumulated during the Promotional Period may be used from 16 June 2022 and no later than 31 March 2027 to request the prizes offered by the Promoter, which consist of rail tickets or other Trenitalia services (previously “rail prizes”), listed in the catalogue published on the website www.trenitalia.com, which is attached to these Rules, in force at the time the prize itself is requested. The use and availability of prize tickets may be subject to limitations, on certain days and for certain routes; the limitations on the availability of prize tickets will be communicated in advance on the website www.trenitalia.com. In any case, the provisions of the General Conditions of Carriage of Trenitalia Passengers apply to the regulation of rail prizes.

In addition to and to expand the prizes, during the duration of the Prize Operation new and/or different products and/or services may be added, even for limited periods, of which due communication will be given on the website www.trenitalia.com.

Upon each request, once the Holder's position and, more generally, the existence of the requirements provided for by these Rules have been verified, the prize will be shipped to the physical address and/or e-mail address, in the case of digital prizes, indicated by the Holder upon the prize request itself.

Once the prize order has been confirmed, the request may no longer be cancelled or replaced, nor will it be possible to modify the contact details indicated at the time of ordering for the delivery of the prize.

The prizes will be delivered free of charge within 180 days of the request date, in accordance with the terms of the law (art. 1 para. 3 of Presidential Decree 430/2001).

In the event of a dispute between a Holder and the Promoter, the latter reserves the right to suspend the assignment of the requested prize(s) until the dispute in question is definitively resolved.

Notes on the prizes:

- The Holder may not, in any case and for any reason, request the monetary value corresponding to the ordered prize, nor the relevant change/substitution thereof; however, the Promoter, in the event that it is unable to deliver the prize due to supervening impossibility for reasons not attributable to it, reserves the right to replace the announced prizes with prizes of similar or superior characteristics, of the same brand and/or of a different brand. Manufacturers' warranties apply to the products.
- The Promoter may in no case be held responsible for any problems arising during the use of the prizes, nor for their improper use by the Holders.
- The Promoter remains extraneous to any dispute that may arise between the winner of the Prize and the supplier thereof, or any other third party, in relation to the use/functioning of the Prize and/or part thereof.
- Except for unforeseen events and/or organizational mishaps, not dependent on its own will and which may in some way prevent the absolute compliance with the set deadlines, the Promoter undertakes to deliver

the prizes, if available, in the shortest possible time from the request date, to the Holder who made the request, and in any case within the terms of the law (art. 1 para. 3 of Presidential Decree 430/2001).

- The photographic images are representative of the prizes.

Art. 14 – Prize fund and security deposit

As security for the prizes promised, a security (insurance or bank) by way of a stamped guarantee or bank deposit equal to 20% of the value of the Prize Fund will be provided; the value of the Prize Fund being estimated at €3,000,000 (three million euros) (excluding VAT), the security deposit will be equal to €600,000 (six hundred thousand euros), subject to final adjustment, expiring on 31 March 2028 and having as beneficiary:

Art. 15 - Information and communication

The publicity of the Prize Operation will comply with these Rules and will be carried out through communications directly to the Holders, on the website www.trenitalia.com and any further forms of publicity that may be deemed useful, always in compliance with and in accordance with the provisions of Presidential Decree 430/2001 on prize events.

Any amendments that, in compliance with the rights acquired by the Holders, should be made to these Rules during the course of the Prize Operation will be communicated in advance to the Holders using the same methods of communication to the public reserved for these Rules.

The Rules will be available for consultation on the website www.trenitalia.com.

Art. 16 - Processing of Personal Data – Privacy Notice on the Protection of Personal Data

Trenitalia S.p.A., as Data Controller, informs the Recipients that enrollment in the Prize Operation entails the processing of personal data for the following main purposes:

- a) Issuing of the Loyalty Card and delivery to the home address for CartaFreccia Oro, Platino and Platino Infinito; Nature of the provision: Mandatory; Legal basis: Contractual
- b) Provision of services connected to the Prize Operation (e.g. crediting of points, booking and seat confirmation in the event of purchase, customer recognition at the call center, etc.); Nature of the provision: Mandatory; Legal basis: Contractual
- c) Registration on the website www.trenitalia.com for the use of the Reserved Area on the website and on the Trenitalia App, through which to enjoy certain benefits: quickly re-purchasing favorite journeys, viewing the history of one's own purchases, easily managing purchased tickets (e.g. for compensation requests), saving travel companions or saving a billing profile with tax code to recall them quickly during purchase); Nature of the provision: Mandatory. Legal basis: Contractual
- d) Promotional and marketing activity by Trenitalia. Nature of the provision: Optional. Legal basis: Consent given upon enrollment in the Prize Operation or in the Reserved Area

- e) Profiling activity by Trenitalia. Nature of the provision: Optional. Legal basis: Consent given upon enrollment in the Prize Operation or in the Reserved Area
- f) Transfer of data to Trenitalia France S.A.S. for the carrying out of promotional and marketing activity by Trenitalia France relating to services that Trenitalia France or other Partners offer from France; Nature of the provision: Optional; Legal basis: Consent given upon enrollment in the Prize Operation or in the Reserved Area.

Any consent given with respect to purposes d), e) and f) is freely revocable at any time, without prejudice to the lawfulness of the processing carried out before the revocation. The revocation of consent may take place by accessing one's own Reserved Area on www.trenitalia.com (Edit data section), or by contacting the e-mail address daticartafreccia@trenitalia.it, or by contacting the Data Protection Officer at the e-mail address: protezionedati@trenitalia.it.

For the purposes of exercising the rights referred to in articles 15-21 of the GDPR, it is possible to send a communication to the dedicated mailbox: daticartafreccia@trenitalia.it or by contacting the Data Protection Officer at the e-mail address: protezionedati@trenitalia.it. The data subject has the right to lodge a complaint with the Supervisory Authority, which in Italy is the Garante per la Protezione dei Dati Personali (Data Protection Authority).

The categories of data processed, the methods and the purposes of the processing are set out in the complete privacy notice available on the website www.trenitalia.com in the “CartaFreccia” section.

Art. 17: Miscellaneous

Participation in the Prize Operation is free of charge.

This Prize Operation is carried out in compliance with Presidential Decree 430/2001 and according to the instructions indicated in circular no. 1/AMTC of 28 March 2002 of the Ministry of Economic Development.

The Promoter reserves the right at any time to verify the regularity of the participation in the Prize Operation by the individual Holder who has not:

- made improper use of their own Card;
- violated these Rules or engaged in behaviors and conduct not compliant with these Rules;
- generally violated legal provisions such as to render participation in the Prize Operation non-compliant;
- provided false/untruthful/fictitious information either at the time of enrollment in the Prize Operation or at any subsequent time, or failed to update such information in the event of a change;
- engaged in conduct that is inconsistent with the Rules and/or non-compliant with legal provisions and/or with the Promoter's G.C.C. (General Conditions of Carriage);
- engaged in conduct that is inconsistent with the Conditions of enrollment and use of the Cards and/or with the Rules of the FRECCIALounge and FRECCIAClub.

During the aforementioned checks and in the event of alleged irregularity in the participation by the Holder, the Promoter reserves the right to undertake any type of action and/or initiative to protect itself, including by way of example the suspension of the Card, with all the consequences relating to the impossibility of enjoying all the benefits connected to the status of the Holder (by way of example and not limitation, access to the High Speed Lounges, redemption of prizes) for the entire time necessary to carry out the checks on the compliance of the Holder's conduct with the Rules and the provisions connected thereto.

The Promoter reserves the right to cancel the Holder's enrollment in the Prize Operation, where there are sufficient elements to ascertain that the latter's behavior is aimed at obtaining an unlawful gain of points or does not comply with these Rules, even partially.

In the event of cancellation of the Holder's enrollment in the Prize Operation, all benefits possibly accrued by the latter will be cancelled.

The Holder whose enrollment in the Prize Operation has been cancelled will be prevented from enrolling again in the same Program, unless otherwise and unquestionably decided by the Promoter.

The Promoter may in no case be held responsible for events not attributable to it that may prevent Holders, even only temporarily, from taking part in this Prize Operation.
